: The Proflow™ *C. difficile* GDH is a qualitative lateral flow test for the detection of *Clostridium difficile* glutamate dehydrogenase (GDH) in faecal specimens. It is intended for use as an aid in the diagnosis of *C. difficile* infections. The test detects GDH and will not differentiate between toxigenic and non-toxigenic strains of *C. difficile*. The results should be considered in conjunction with patient history and additional laboratory investigations. This test is intended for laboratory use only.

SECTION 4: First aid measures

4.1 Description of first aid measures

Eye contact

: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 20 minutes. Get medical attention if irritation occurs.

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel.
